

CHSRA DISTRICT 4 CONTRACT

AGREEMENT TO PARTICIPATE AND BE A MEMBER IN GOOD STANDING IN THE CALIFORNIA HIGH SCHOOL RODEO ASSOCIATION

In applying for membership to CHSRA District 4, I _____ (member's name) agree to participate at my district level according to the following terms:

1. I agree to submit a current report card/progress report at the completion of each grading period to the District 4 Membership Secretary, Kori Hitchcock (HS) or Nita Nino (JH).

"REPORT CARDS": A copy of the member's most current report card MUST be to the MEMBERSHIP SECRETARY prior to CLOSE OF ENTRY DATE. It is the responsibility of the contestant to get the report card to the secretary within one week of the report cards being issued by the school. If Membership Secretary does not have the most current report card at the time of close of entries, the member will not be able to rodeo and will forfeit all current entries. Emailed copy will be accepted. Students attending non-traditional schools must still provide a report card at the end of each grading period.

2. I agree to perform my assigned rodeo duty at each of our District 4 Home Rodeos (i.e. banners, events or trash pickup.)

CONTESTANT RODEO WORK DUTY": Every member of District 4 entered in the rodeo will be assigned work duty except event directors. If a member does not fulfill their duty assigned and does not get their card signed off by the adult event director and back to the rodeo secretary at the end of the rodeo, a \$25 fee will be assessed and the member will be considered in "bad standing" until the fee is paid.

3. I agree to submit Sponsorship of a minimum \$500 (HS) or \$300 (JH), by **November 1st, 2020. Members will forfeit entries to the next rodeo if this is not received by the due date.**

4. I agree to sell the **15 MANDATORY CHSRA Raffle tickets at \$10 each.** All the proceeds go to the CHSRA Scholarship fund. All raffle tickets and money are **due** at or before our **January Rodeo.**

5. I understand that, should I become "not in good standing" I must write a letter to the District 4 Board to request my membership be restored to "good standing".

6. I understand that in order for CHSRA D4 to be able to produce safe, fair and quality rodeos, we encourage parents to participate in District 4 activities as an "ASSOCIATE MEMBER".

7. I understand that in order to qualify for year-end awards, I must participate in no less than 50% plus one rodeo per event on the 2020-2021 District 4 calendar.
8. I will provide a **MANDATORY** (1) auction item of \$50 value or more for the **King City Invitational Rodeo**. (Because of Covid-19, this might not occur).
9. I will follow new rules of social distancing and wearing a mask when needed or asked at each rodeo because of COVID-19.

IF I FAIL TO FULFILL THE TERMS OF THIS AGREEMENT AND ADHERE TO THE DISTRICT 4 POLICIES (BI-LAWS) OF CHSRA AND DISTRICT 4, I WILL NOT BE A MEMBER IN GOOD STANDING. I UNDERSTAND THAT IF I AM NOT A MEMBER IN GOOD STANDING, I MAY FORFEIT FROM COMPETING IN FUTURE CHSRA RODEOS. I FURTHER UNDERSTAND THAT IN ORDER TO RECEIVE YEAR-END AWARDS, I MUST BE A MEMBER IN GOOD STANDING.
